Functions & Responsibilities of the SC/ST Cell / Committee:

1. To address and resolve any grievances of SC/ST students, teachers, officers and employees relating to caste-based discrimination / harassment
2. To monitor implementation of reservation policy in admission, appointments, scholarships and other benefits
3. To ensure strict compliance with UGC / Government of India / State Government guidelines on prevention of caste discrimination
4. To organize sensitization programmes, workshops, seminars and awareness campaigns
5. To recommend remedial measures, special coaching, scholarships and welfare schemes
6. To submit periodic / annual report of activities and grievances disposed to the Vice Chancellor

Tenure: The Committee shall function for a period of two years from the date of this order or until further reconstitution, whichever is earlier.
